| <p>About BENSOC</p> | <p>Selected and presented with 'The 2012 NSW Government Award for Outstanding Achievement in Community Service'</p> <p>BENSOC Members have contributed just over a Million Dollars, since inception in 1993, as benefit payment to 218 families of fellow members towards their funeral expenses, as at 15 Jul 15.</p> <p>There are currently(01 July 2015) 646 members.</p> |
| <p>Eligibility for Membership</p> | <p>Men over the age of 55 and women over the age of 50.</p> <p>Members of TSCA who have been residing in New South Wales, as Citizens/Permanent Residents of Australia, for a minimum of one year.</p> <p>Applicant is eligible to join if the application was made before the 75th birthday.</p> <p>However, in the case of an applicant over the age 75, the applicant shall still be eligible if the Permanent Resident Visa was granted not earlier than 2 years.</p> |
| <p>Fees & Contribution</p> | <p>Application Fee of \$20.</p> <p>One-off contribution of \$60 at the time of application.</p> <p>Will not be called upon to contribute for calls during the first 6 months of membership.</p> <p>Eligible for the benefit payment, only after the completion of the 6-months membership</p> <p>Call dues must be paid on time. When these dues are paid in advance eg. \$200, \$100 etc., it greatly reduces the administrative workload of our volunteer Board of Trustees.</p> <p>Additional Age Contribution of \$220 for every year over the age of 60 (Calculation is based upon the Age Next Birthday at the time application. Example - An applicant whose Age Next Birthday, at the time of application, is 62 pays 2@\$220 = \$440).</p> |
